I hereby expressly agree for myself and my principals, representatives, employees and agents; ***(1) to be bound by the rules and bylaws and any rules of this Competition; (2) that every horse, rider, groom, trainer, exhibitor is eligible as entered; and (3) to accept as final any decision of the Competition officials on any question arising under the rules and by-laws or any rules of the Competition, and agree to hold the A North American Gypsy Affaire LLC its officers, directors, employees and agents, and Competition judge(s), officials and organizing committee, harmless for any action taken.
